The AFCIV Manual and Reimbursement Guidelines is intended to provide thorough instructions on all AFCIV features and provide instructions on issues such as expense reimbursement, payment of experts, payment for transcripts, etc. The Attorneys for Children Program continues to seek new ways to help you serve your clients. Your suggestions are welcome. If I can assist you in any aspect of your service as an attorney for children, please do not hesitate to contact me.

We wish you the greatest success in your work as an attorney for children and in every other aspect of your legal career.

COMPENSATION AND REIMBURSEMENT GUIDELINES

Attorneys for Children (AFC) Program Payment Policies

A. Compensation for legal services

1. Panel Membership Required

- a. An attorney must be a member of a county AFC panel to be compensated by the AFC Program for representing a child in Family, Supreme or Surrogate's Court.
- b. Panel members must comply with the attorney registration requirements of Judiciary Law § 468-a, and are expected to notify both the OCA Attorney Registration Unit and the AFC Program with any change of contact information.

2. Time Records

- a. AFC must maintain sufficient real-time records and documentation to ensure that vouchers submitted reasonably and accurately reflect services provided to attorney for the child clients. AFCIV requires a start time and time spent in hours/minutes for in-court and out-of-court activities.
- b. All AFC vouchers are subject to audit both before and after payment. You are required to keep sufficient documentation in your records to ensure you can justify charges on vouchers. Should you be audited, your records will be expected to have been created reasonably close to the time you performed the activity.

3. Billing Practices that May Trigger Audit

- a. Standard Charges/Minimum Billing - e.g., there are 25 instances of "review documents" on one voucher, all of them billed at .5 [in real-time all billed as 30 minutes]; there are 100 instances of telephone conversations, spread over 5 vouchers, all of them billed at .2 [in real-time all billed as 12 minutes]. Not only is this improper, in real-time, it is impossible.
- b. Charging Staff Time - You cannot charge for your secretarial/paralegal staff time or for time spent by other attorneys in your office.
- c. Overcharging for Review or Preparation of Form Letters - e.g., ordinarily it does not take 30 minutes to review or prepare a form letter.
- d. Charging Overhead/Administrative Costs - This includes charging for sending a fax, map-questing, filing, copying, calendaring, preparing a voucher, etc. The statutory rate of \$75.00 per hour is for legal work only.
- e. Excessive Charges for "Review File" or "Open File" - If you are charging significant time to review or open file, be sure you have documentation in the file that would justify the time spent.
- f. Excessive Charges for "Research" - Charges for legal research matters about which attorneys are presumed to know, e.g., basic Family Law issues.

4. Compensation Rate

- a. The compensation rate for in-court and out-of-court time is \$75.00 per hour.

5. Client Contact

- a. One of the primary responsibilities of an AFC is to contact, interview, regularly meet and remain accessible to your client. Every voucher should contain information indicating that the attorney has met with his/her client.
- b. In the event the AFC has not met with his/her client(s), e.g., there is no time billed under activity code "B-Client Contact" on the voucher, the attorney must attach to the voucher an affirmation setting forth the reason(s) for not meeting with the client. The voucher will be returned if the affirmation is required but missing.
- c. The AFC Program reserves the right to disallow or to request additional documentation to support any claim for compensation that fails to include client contact.

6. In-Court and Out-of-Court Time

- a. In-Court time is time spent at court facilities in conjunction with an appearance before a judge. In-Court time includes:
 - i. Time spent in the presence of the judge either in the courtroom or in chambers.
 - ii. Time spent in a court-ordered conference at court facilities in conjunction with an appearance.
 - iii. If in-court time is "off the record," e.g., not recorded in UCMS, you must document in your file why the time is in-court time, e.g., pre-trial conference in chambers.
- b. All other time expended in representing an AFC client, including time spent at court facilities for purposes other than an appearance before a judge, e.g., reviewing files, meeting with the client, waiting for the case to be called, is out-of-court time.
- c. The maximum claim for in-court and out-of-court services for one day is eight hours, unless the voucher is accompanied by a brief statement setting forth the reasons why greater time was required.

7. Representation in Collateral Matters

- a. An AFC may be compensated for representation of a client in a legal or administrative matter collateral to the court proceeding for which the AFC was assigned when:
 - i. The collateral matter arises from the same circumstances as the assigned court proceeding; and
 - ii. Representation by the AFC in the collateral matter is required to assure the most favorable outcome for the client in the assigned court proceeding.

8. Voucher Preparation

- a. AFC may not charge for time spent preparing vouchers or affirmations for the voucher.

9. Double Billing

- a. Double billing is the practice of rendering legal services on multiple cases in a given period, and then requesting payment for the entire period on the voucher for each case. For example, waiting at court one hour for two cases to be called and then requesting payment for one hour for each case. Another example is charging travel time to court for each case when the AFC appears in court on more than one case.

B. Expenses of Representation

1. In General

- a. The AFC Program will pay reasonable expenses connected to the representation of the client. Charges for expenses such as buying the client lunch are not reimbursable.
- b. Expenses for in office computer-assisted legal research, e.g., Westlaw or Lexis, and facsimile transmission (fax) are considered office overhead costs and will not be reimbursed.
- c. Expenses must be broken down, e.g., number of stamps, number of copies, etc.

2. Travel/Mileage

- a. Travel includes drive time only. Parking or walking to the courthouse is not reimbursable.
- b. Reimbursement for travel and mileage will be as reflected on the shortest time on MapQuest.
- c. Travel and mileage reimbursement must be from the address listed in your AFC Profile. If the address listed in your AFC Profile is a P.O. Box you must provide the AFC Program your physical office or home office address.
- d. The AFC Program will not reimburse for round trip travel and mileage under 5 miles. This limitation applies to all activities, in-court and out-of-court.
- e. The 35/35 Rule: Beginning with activities dated October 1, 2012, the maximum reimbursement for travel to and from court is 35 miles/35 minutes each way. This limitation does not apply to out-of-court activities, such as meeting with clients and attending service plan reviews. The limitation does not apply to attending oral argument on appeal.
- f. You may charge a maximum of two round trips per day to the courthouse if there is at least one-half hour you could be in your office between trips.
- g. You must obtain approval from the AFC Program for any out-of-state travel.
- h. Mileage is reimbursable at the statutory rate.

- i. Tolls are reimburseable with receipts.
- j. Parking fees are reimbursable up to \$5.00 without receipts.
- k. Other travel expenses, including food and lodging, generally are not reimbursable.

3. Transcripts

- a. Transcript charges greater than \$300.00 must be approved by the AFC Program Director or Deputy Director. This limitation does not apply when the child client is the appellant on an appeal. *Do not pay for transcripts.* The AFC Program pays the transcriber directly. Please see page 10 for information on obtaining trial transcripts.

4. Miscellaneous Expenses

- a. Printing and photocopying expenses will be reimbursed at the rate of \$.15 per page. Please specify the number of copies and provide a description of what is being copied, e.g., 4 copies at \$.15 - copies of Order Appointing AFC.
- b. Other itemized out of pocket expenses, such as postage, are reimbursable without additional documentation to a maximum of \$15.00.
- c. Reimbursement claims for more than \$15.00 must be documented by receipt or some other proof of payment.
- d. If the AFC Program is responsible for the service of process and subpoena and witness fees, we will reimburse the AFC on the voucher. If the cost of service of process or subpoena and witness fees will be over \$100.00, you must contact the AFC Program Director for prior approval.
- e. **There will be NO reimbursement for printing of records and briefs (they should be copied), filing and service of records and briefs, or for professional preparation of records and briefs.**
- f. The AFC Program is generally not responsible for the cost of medical records. If the AFC Program is responsible for the cost of medical records, we will reimburse the AFC on the voucher with a copy of the invoice and a copy of the proof of payment. If the cost of the medical records will exceed \$50.00, you must contact the AFC Program Director for prior approval.

C. Preparation of Attorney for Children Vouchers

1. Submission of voucher required

- a. To receive compensation for legal services, the AFC must use the Attorneys for Children Internet Voucher System (AFCIV). In order to attain access to AFCIV you must have a user name and password. If you do not have a user name and password, please call the AFC Program to register your online account.

2. When to submit vouchers

- a. AFC vouchers should be submitted to the court as soon as possible after the proceeding has concluded.

- b. Voucher must be billed by File #, not by Docket #. For example, if a File # has three Dockets, do not bill each Docket # separately.
- c. Submission within 90 days:
 - i. If the voucher is submitted on AFCIV more than 90 days from the last activity date a "Warning Requiring Affirmation," will appear with the exact number of days the voucher is overdue. In such cases, you must complete an affirmation explaining the reason for the delay in submission.
 - ii. The Appellate Division may reject any AFC voucher submitted more than 90 days after disposition. While we afford you great latitude with this rule, no voucher payment will be considered if the voucher is submitted more than three years after the last valid activity date on the voucher. Vouchers submitted one to two years after the disposition will be considered on a case-by-case basis, but the excuse that the AFC did not have time to bill will not be acceptable.

3. Interim Vouchers

- a. With prior approval of the AFC Program, an interim voucher must be submitted during the pendency of a proceeding if any of the following circumstances exist:
 - i. Extraordinary Circumstances - The voucher exceeds \$4400.00 in services or over 18 months of consecutive work without reaching disposition.
 - ii. At the disposition phase of a case where permanency hearings are mandatory.
 - iii. An AFC is removed from a pending case.
- b. Make your request for an interim voucher to the AFC Program. Be sure to indicate your AFCIV Document ID Number and the reason for the request. The Document ID Number can be found on the Open Voucher screen on AFCIV.
- c. The AFC Program cannot approve interim vouchers on appellate matters.

4. Integrated Domestic Violence (IDV) Court Vouchers

- a. Cases that start in Family Court and are subsequently transferred to IDV Court are regarded as separate proceedings requiring preparation and submission of separate vouchers.
- b. The first voucher should contain all the activities completed in Family Court up to the date of transfer. The second voucher should be created by selecting the appropriate Supreme Court with activities from the date of transfer to the completion of the case.

5. Raise the Age Vouchers

- a. Time spent in the Youth Part will be paid by the County 18B program.

- b. For cases sent to Probation Adjustment, the AFC will complete a voucher on AFCIV. The AFC will select the county Supreme Court and use the Proceeding Code "RTA - Probation Adjustment" and enter the Felony Youth Complaint (FYC) Docket #.
- c. For cases removed directly to Family Court without going to Probation Adjustment, the AFC will bill under the county Family Court as they would for a routine Juvenile Delinquency (JD) Proceeding.

6. Appeal Vouchers

- a. A trial court action and a subsequent appeal are regarded as separate proceedings, requiring the preparation and submission of separate vouchers.
- b. You should prepare the appeal voucher on AFCIV; however, be sure to select the Appellate Division, Fourth Department for the court and AP for the Proceeding Code. When asked for the case number, enter the CAF number.
- c. For Oral Argument, please use the N Code, In-Court All-Other. In-Court time is time spent in the presence of a judge. Any time spent waiting for Oral Argument should be billed using the H Code, Out-of-Court All-Other.
- d. If you do not attend Oral Argument, please provide an affirmation explaining why you did not attend, e.g., the parties submitted.
- e. Client Contact - You must see your client, regardless of age. This rule applies to appeals as well.
- f. Make sure that you provide adequate description for all charges, in-court and out-of-court, e.g., if you charge an A Code, Review of Documents, you must specify what document(s) you are reviewing. Please see page 13 for a complete list of activity codes and required descriptions.
- g. The AFC Program does not pay for "overnight" or express mail postage fees to file a brief.
- h. The AFC Program does not pay for fees to professionally prepare and/or file and serve records and briefs.
- i. Once you have completed the voucher, send the original (no copy needed) to the AFC Program. Along with the voucher, please send a copy of your brief, a copy of the Appellate Division decision and any required receipts.
- j. For more information on appeal vouchers, please refer to the Appeal Voucher Q & A starting on page 61.

7. Substitution of AFC in Trial Courts

- a. The AFC substituting will prepare his/her own voucher for time spent. See page 43 for instructions.
- b. Substitution is only acceptable when required by an unavoidable circumstance. The assigned AFC requesting that another AFC be substituted must receive prior approval of the court and the client (where age and maturity of the client permit); the appearance must involve only procedural or administrative issues unrelated to the substantial interests

of the client; the substitute AFC must be a panel AFC and the substitute AFC must be fully prepared for the appearance.

8. Substitution of AFC on Appeal

- a. Submit a letter requesting substitution on appeal to the Deputy Director of the AFC Program.
- b. Sign the letter yourself (no secretary's signature, stamped signature, etc.).
- c. CC all counsel and any pro se parties on the letter requesting substitution.
- d. Along with the letter requesting substitution, please enclose copies of the following:
 - i. Notice(s) of Appeal
 - ii. Affidavit of Service if the AFC served a Notice of Appeal
 - iii. Order(s) appealed from
 - iv. Decision, if any
- e. A member of the AFC Appeal Panel will be substituted by the Appellate Division.
- f. The appellate AFC will prepare his or her voucher in accordance with the requirements set forth on page 7.

EXPERT SERVICES

A. The Attorneys for Children Program has the authority to pay reasonable expenses of representation, e.g., compensate non-attorney experts, such as investigators, physicians, mental health professionals and social workers, for services on behalf of attorney for the child clients that are necessary to assure effective representation. In Supreme Court cases only, if the AFC is compensated pursuant to Part 36 (private pay), any experts must also be privately paid for services on behalf of AFC clients. Please use the model order for expert services which is located on the AFC Program website under forms/AFC forms.

B. Authorization and Allocation

1. If the expert fee will be greater than \$1000.00 you must obtain authorization from the AFC Program Director or Deputy Director.
2. Services to the Child Only
 - a. The AFC Program is responsible for the full cost of expert services provided solely to the client.
3. Services to the Child and Participants Jointly
 - a. The AFC Program is responsible for a proportionate share of the cost of expert services when those services are provided jointly to a client and other participants in a proceeding.
 - b. When services are provided jointly to all participants in a proceeding, the trial court order should allocate the cost of services among the participants. If a participant is indigent, generally that part of the cost is paid by the county pursuant to Count Law § 722-c.
4. Services Not Reimbursable
 - a. The AFC Program is not authorized to pay for expert services to participants in a proceeding other than the client, or for services unrelated to the client's representation, such as treatment or counseling.
5. Compensation Guidelines
 - a. The Chief Administrator of the Court has adopted the following hourly rates, effective January 1, 2018 as guidelines for payment of non-lawyer professionals under Judiciary Law § 35 and County Law § 722-c:

i.	Psychiatrist	\$250.00
ii.	Certified Psychologist	\$150.00
iii.	Physician	\$250.00
iv.	Certified Social Worker	\$75.00
v.	Licensed Investigator	\$55.00

C. Payment to the Expert Service Provider

1. The expert is compensated directly by the AFC Program after the services have been rendered. Please submit a completed JC2020 form, Order Authorizing Expert Services and a copy of the Invoice for Services to the court for the Judge's signature. The JC2020 is located on the AFC Program website under forms/AFC forms.

TRIAL TRANSCRIPTS

A. An Attorney for the Child can obtain transcripts for use in representing a client either at trial or on appeal by using the New York State Law Guardian Minute Order Form. The stenographer or transcriber provides the transcript directly to the AFC who incurs no out-of-pocket expense because the transcript costs are paid by the AFC Program directly to the stenographer or transcriber. Do not pay the stenographer directly. A motion for poor person relief is not required.

B. The budget for transcripts is limited. No permission is required when obtaining an original and copy of a transcript when the child is the appellant. Where the child is the appellant, the AFC must make arrangements to order transcripts necessary to a determination of the appeal. The transcripts will not automatically be ordered for you. Clearly indicate on the paperwork that the transcripts are for an appeal.

C. Under the statewide Practice Rules of the Appellate Division, implemented in September 2018, per NYCRR 1250.9, on concurrent appeals from a single order or judgment, or on cross appeals, the appealing parties shall file a joint record and shall share equally the cost of the record. Accordingly, if you are appealing as AFC, and another party is also appealing, please contact the other party and make arrangements to split the cost of the record, including transcripts. The AFC Program will not pay for professionally produced records.

D. For use at the trial level, only one transcript is authorized and you must obtain permission if the cost will exceed \$300.00. An AFC can obtain a Minute Order Form from the Family Court Clerk's Office or the AFC Program website. Once you have obtained the Minute Order Form, complete the following steps:

1. The AFC completes the top portion of the Minute Order Form and presents the form to the corresponding Family Court Judge for signature.
2. Following the Judge's signature Family Court retains a copy of the form and returns the original form to the AFC for transmittal to the stenographer or transcriber.
3. Upon receipt, the stenographer or transcriber prepares two certified copies of the transcript. One copy is to be filed with the Family Court Clerk and the other copy is delivered to the AFC.
4. When the transcript is delivered, the AFC must sign the appropriate portion of the Minute Order Form.
5. The stenographer or transcriber retains a copy of the form and forwards the originally signed Minute Order Form and a Claim for Payment to the AFC Program for review and payment. A copy of the Claim for Payment form is available on the AFC Program website under Forms/AFC Forms.
6. At the trial level, the rate for transcript preparation is \$2.50 per page. For appeals, the rate is \$2.50 per page and \$1.00 per page for a copy.

Expenses Not Reimbursable

Filing Fees: Children are deemed poor persons. Therefore, any filing fees are waived and the AFC Program will not reimburse for filing fee costs.

Administrative Expenses: Including, but not limited to cost of computer assisted legal research, e.g., Westlaw or Lexis, facsimile charges, preparing a voucher, paralegal fees.

ACTIVITY CODES & DESCRIPTIONS

Out-Of-Court (Do not combine activity codes)

A. Review of Documents - Describe the documents reviewed, e.g., "Reviewed petition and file."

B. Client Contact - This code should only be used for client contact. If the meeting was in-person, please include the location where you met with your client, e.g., "Meeting with client at School #123 Main St., Rochester, NY 14604."

C. Travel - Indicate where you traveled to and from, e.g., "Travel from Office to Court." For any travel other than to and from court, you must include, at minimum the street name, city or town and zip code of the destination you traveled to and from, e.g., "Travel from Office to Respondent Mother's house at Alphabet St., Rochester, NY 14604." Reimbursement for travel will be as reflected on Map Quest for the shortest travel time.

D. Phone/Correspondence - Indicate who you communicated with and how, e.g., "Call to Mother's Attorney."

E. Legal Drafting - Indicate the document type drafted and subject, e.g., "Draft Temporary Order of Custody and Visitation."

F. Legal Research - Indicate the subject of research, e.g., "Legal research, research case law on Grandparent Visitation."

G. Investigation - Indicate what is being investigated, e.g., "Meeting with witness to discuss events involving client."

H. Out-of-Court All-Other - Covers any other work you may have been doing related to representing your client, e.g., "Waiting for case to be called."

In-Court Codes (Do not combine with Out-of-Court codes; do not use same code for all court appearances)

J. Initial Appearance - Provide a brief description of what occurred, e.g., "Initial appearance in front of Judge Smith. Adjourned to allow parties to obtain counsel."

K. Pre-Trial Hearing - Provide a brief description of what occurred, e.g., "Hearing on removal in front of Judge Smith."

L. Fact-Finding - Provide a brief description of what occurred, e.g., "Trial commences in front of Judge Smith."

M. Disposition - Provide a brief but specific description of what occurred, e.g., "Parties agreed to joint custody. Primary physical with Mom, liberal visitation to Dad."

N. In-Court All-Other - Provide a brief description of what occurred, e.g., "Appear before Judge

Smith to enter Temporary Agreement on record.”

Expense Codes

P. Expense - Please indicate the type of expense, e.g., copies, postage, and the quantity. Specify the number of copies and provide a description of what is being copied, e.g., 4 copies at \$.15 - copies of Order Appointing AFC. In the expense box, enter the total amount, excluding the \$ symbol.

Q. Mileage - In the activity description, indicate the mileage to and from, e.g., “Mileage to and from court.” In the mileage box, enter the total number of miles. AFCIV calculates the mileage rate automatically based on the number of miles you enter.

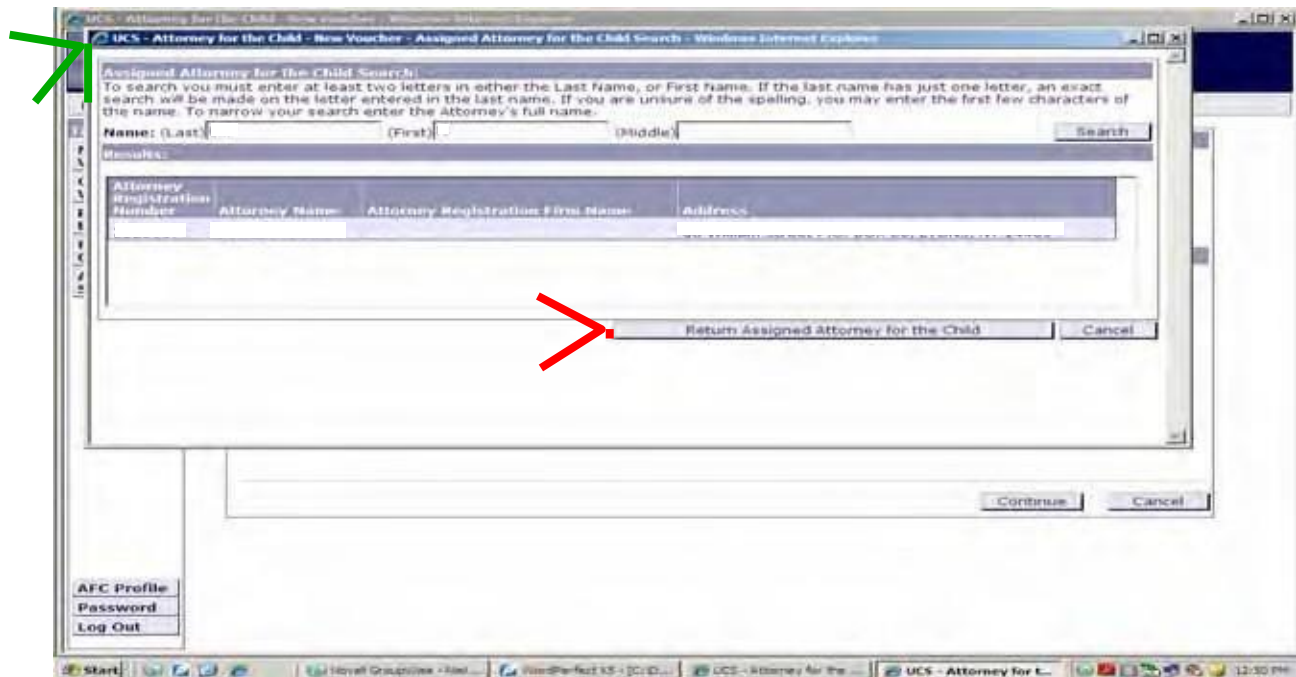





(Displayed Below) The “Un-Vouchered Dockets” report can be used to assist you in figuring out whether you’ve billed a docket or not. However, it is important to note that just because a docket is listed in the “Un-Vouchered Dockets” window, it does not necessarily mean that you haven’t billed time on the File.

Find Conflicts

There are three types of conflicts that can appear in the warnings section of your voucher. All three can be resolved by using the “Find Conflicts” button on your AFCIV task bar. The AFC Program strongly suggests that you research and resolve any conflicts before submission. The three conflict warnings are:

1. “Document ID: 123456 contains overlapping activity dates for docket V-12345-13.”
2. “Total # of hours for in-court and out-of-court activity(s) dated 10/24/2012 exceeds 12.00 hours.”
3. “The start and end time for Review of Documents dated 10/24/2012 overlaps with an activity on Document ID: 654321.” **Note: This third warning is fatal and must be resolved prior to submission of the voucher. This warning can also be resolved by viewing the time slots for given date(s) or document id number through the “Generate an Activity Extract” Report.**

After you click the “Find Conflicts,” a “Find and Resolve Voucher Conflicts,” window will appear. Enter the “Document ID” that contains conflict warning(s) and hit, “Search.” (Displayed Below)



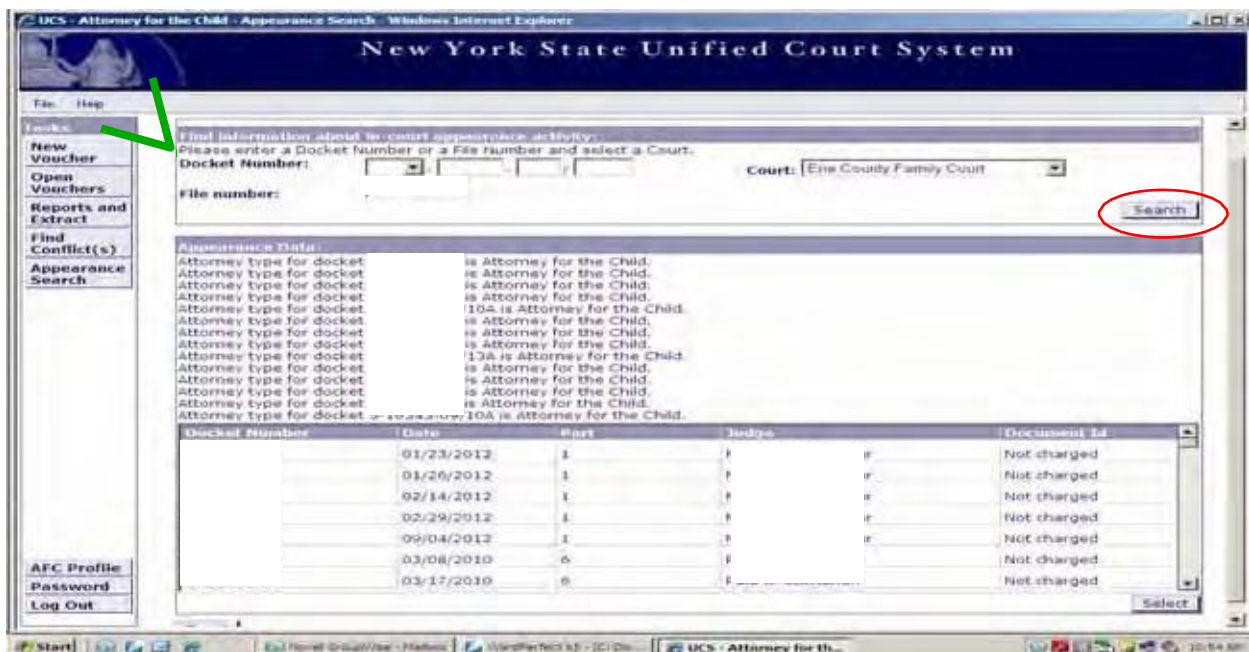
After you click “Search,” a conflict search results window will appear showing the activities that are causing the conflict. You can then use the information provided to resolve the conflict warning on your voucher.

Appearance Search

The “Appearance Search” button on the task bar can be used to find information about an in-court appearance. To start, click on “Appearance Search.” (Displayed Below)



If you want to see what appearances are associated with a specific docket, enter the “Docket Number,” and select the “Court” from the pull-down menu and click “Search.” You may also search for appearances related to Family File #, to do so, enter the “File Number,” select the “Court,” and click “Search.” (Displayed Below)



Attorneys for Children Internet Voucher System (AFCIV) Frequently Asked Questions

I cannot remember my user ID. What is it?

Generally, your user ID is either your first initial, last name, all lower case, one word or your attorney registration number.

I do not remember my password for AFCIV. Can you tell me what it is?

We do not have access to password information but you can use the following link to create a new password: <https://iapps.courts.state.ny.us/sspr/Forgot> Please bookmark this link so that if you forget your password in the future, you'll be able to reset without delay.

AFCIV won't accept my password. What are the rules for the password?

1. Password must contain a minimum of 10 characters
2. Password must contain three of the four: upper case, lower case, number or special character
3. Password cannot be one you have ever used before
4. Password cannot contain your name or user ID

I noticed some information in my AFC Profile is incorrect. Is it important to keep it up-to-date?

Yes, it is extremely important to keep your AFC Profile up-to-date. Through AFCIV you can update your phone number(s) and email address and our office will be automatically notified of the update.

The address associated with my Vendor ID/Firm Vendor ID is wrong, but it won't let me update the address through the AFC Profile. What should I do?

Please contact the AFC Program to make sure we have the correct address in our internal database. In order to update the address associated with your Vendor ID Number you will need to log in to the Statewide Financial System (SFS) Vendor Portal.

How do I update my information in the SFS Vendor Portal?

First, obtain a user ID and password for the Vendor Portal by contacting the SFS Help Desk by phone: (855)233-8363 or (518)457-7717 or by email: helpdesk@sfs.ny.gov.

To access the Vendor Portal go to www.sfs.ny.gov. Once you sign in go to "Supplier Change Request," click "Address," click "Edit." After editing the address, click "Submit

Icon” along the top of the screen. Select a “Reason for Change” enter comments if you have any, click the box “Confirm Changes” then click “Submit.”

If you do not see the address change reflected automatically in your AFC Profile within two weeks of submitting the change request, please contact the AFC Program.

Can my AFC Voucher Payments be paid by Direct Deposit?

Yes, your AFC Payments can be paid by Direct Deposit. You will use the Vendor Portal to register for Direct Deposit.

First, obtain a user ID and password for the Vendor Portal by contacting the SFS Help Desk by phone: (855)233-8363 or (518)457-7717 or by email: helpdesk@sfs.ny.gov.

To access the Vendor Portal go to www.sfs.ny.gov. Once you log in to the portal click “Register for ePayments,” then under “Supplier Inquiry Results” click your “Supplier” Number (Vendor ID). After that enter your information, check the box by “I Hereby” and click “OK.”

I was assigned to represent three siblings. The case has more than one Family File # but was handled together by the court. Do I have to prepare three separate vouchers?

So long as the case was handled together, you can bill more than one Family File # on the voucher. When you create the voucher you will just want to add each of the Family File #'s to the “Selected File #” field and then click “Continue.”

I was assigned to a Family File # previously and submitted a voucher for my work. The Petitioner has since re-filed and I was re-assigned. The case was given the same Family File # but with a new petition. When I go to start a new voucher for my work, the voucher system states that a previous voucher has been billed. How do I start a new voucher for my work?

If you receive a message that “Document ID xxxxxx for Family File # xxxx with activities dated xx/xx/xxxx to xx/xx/xxxx has been sent to OSC” take note of the dates previously billed, exit out of the message and click “Continue” a second time. This will allow you to create a new voucher for any un-billed time.

When I enter the Family File # I receive a warning that the File # is invalid with the selected court or I have not been assigned to the File #. I checked my file and I was assigned as an Attorney for the Child on the matter. What do I do?

Generally, the error message means that the court has entered your assignment incorrectly in the court's database, UCMS. Please contact Amy at the AFC Program at ahugyecznyc@nycourts.gov for instruction to correct the assignment.

I am working on a Supreme Court voucher and it is asking for a “Case Number.” What number should I input?

Input the Index Number or the IDV File Number. Please remember that when submitting a voucher for divorce/matrimonial action you are required to attach the Order Appointing you as a State Pay Attorney for the Child to the AFC Voucher.

I was able to create the Supreme Court voucher, but none of my court appearances are available in the drop down menu as they are on a Family Court voucher. Should I contact the court?

No, on a Supreme Court voucher you will select an in-court code and enter the date manually as you would with an out-of-court activity.

I have a case that originated in Family Court but was subsequently transferred to IDV Court. Do I have to prepare two separate vouchers?

Yes, you will need to complete two separate vouchers. One under the Family Court up to the date of transfer and another under Supreme Court from the date of transfer through disposition. You can submit the Family Court voucher as soon as the case is transferred.

I am working on a Family Court voucher and there is a warning that states, “UCMS records indicate you were not present for Pre-Trial Hearings on 07/27/2020. Your attendance must be corrected with the court in order to bill for this appearance.” I know I attended this court appearance. How can I fix it?

Please contact Amy at the AFC Program at ahugyecz@nycourts.gov. Amy can check UCMS, locate the Docket #(s) that the AFC is marked not present on and provide instruction so that the court can correct.

The court confirmed they marked me present on the Docket #(s) provided but the warning is still at the bottom of my voucher. What should I do?

Please delete and re-add the court appearance to refresh the data.

I have a warning on the bottom of my voucher indicating that there is a conflict between activities. How do I resolve?

The best way to resolve a time conflict is to use the “Generate an Activity Extract” report. To do so, click “Reports and Extract,” select “Generate an Activity Extract,” enter the date of the conflict to the same date in “MM/DD/YYYY” format, click “Sort By: Activity Date,” click “Search.”

A window will open that will show you all of the activities billed by the AFC on that date for all of their AFC assignments. You should be able to see the time conflict and resolve accordingly.

I have a warning on the bottom of the voucher stating that an affirmation is required. I saved the affirmation. Why is the warning still on the voucher?

The warning that indicates an affirmation is required will always remain on the voucher. When you are ready to submit the voucher, just click "Submit and Print Voucher." A final affirmation screen will appear where you can preview what you have saved, you will check a box under "Warnings Requiring Affirmation, and click "I Affirm." A PDF of your voucher should then pop up in your window so that you can print.

I have a warning on the bottom of the voucher stating that I cannot submit because the case is not disposed of. How do I request interim submission?

The AFC Program can approve interim vouchers under the following circumstances:

1. AFC has been relieved of assignment
2. At the disposition phase of a case where permanency hearings are mandatory
3. Extraordinary Circumstances - The voucher exceeds \$4400.00 in services or over 18 months of consecutive work without reaching disposition

To request, please provide the Document ID Number for the voucher and an explanation of the reason.

When I created the voucher I did not input the disposition. How do I get back to enter the disposition?

To return to the screen where you enter the disposition click, "Open Voucher," highlight the voucher, click "Select to Update," this will load automatically to the Activity Sheet, click the tab titled "Dockets" (Top/Left), enter disposition.

I was able to submit my AFC Voucher, but the voucher did not pop up for me to print and submit. What should I do?

Disable your pop up blocker then run a "Submitted Voucher Report" to generate a copy of the PDF. To do so, click "Reports and Extract," select "Submitted Voucher Report," enter the date range within which you submitted the voucher electronically in "MM/DD/YYYY," click "Sort By: Submitted," click "Search." Highlight voucher you need a copy of and click "Print Preview Voucher."

In reviewing my submitted voucher, I noticed that some of the time was entered incorrectly. Can I manually change or do I need to prepare a whole new voucher because the voucher is no longer available in the "Open Voucher Folder?"

Contact Amy at the AFC Program at ahugyecz@nycourts.gov. Amy can return the voucher electronically to your “Open Voucher Folder,” so that you can make corrections and re-submit and print.

Is there a way I can tell if the AFC Program has received and processed a voucher for payment?

Yes, you can use the “Submitted Voucher Report” to see if a voucher has been received and processed for payment. Log on to AFCIV, click “Reports and Extract,” select “Submitted Voucher Report,” enter the date range within which you submitted the voucher electronically in “MM/DD/YYYY” (up to one year), click “Sort By: Submitted,” click “Search.”

If you see an “Appellate Receipt” date listed that means that the AFC Program has received and processed the voucher for payment. Generally a check is cut within a week to ten business days of that date. If the voucher has not been received by the AFC Program and it has been over a month, please re-submit the voucher to the court for judge’s signature. If you see an “Appellate Receipt” date but have no record of receiving a payment, please contact Amy at the AFC Program at ahugyecz@nycourts.gov for assistance.

As you work on AFC vouchers, if you have any questions, please feel free to contact Amy at ahugyecz@nycourts.gov for assistance. Please provide a detailed explanation of the problem you are experiencing or question you have. Thank you!

Appeal Voucher Q & A

Q: Am I required to meet with my client on appeal?

A: Pursuant to Section 7.2 of the Rules of the Chief Judge, the AFC must consult with and advise the child to the extent and in a manner consistent with the child's capacities, and have a thorough knowledge of the child's circumstances. *See Matter of Mark T. v Joyanna U.*, 64 AD3d 1092 (3d Dept 2009); *Matter of Jennifer V.V. v Lawrence W.W.*, 241 AD3d 622 (3d Dept 2020). If you do not meet with your client, you are required to submit an affirmation explaining why you did not meet with your client. Encountering difficulty in scheduling a client meeting does not excuse you from this duty.

Q: How do I voucher for an appeal?

A: You will complete a voucher for appeal on the Attorneys for Children Internet Voucher System (AFCIV).

Q: Can I just combine the lower court work with the work completed on appeal?

A: No. You must complete two separate vouchers. One for the work completed at the Family Court or Supreme Court level and one for the work completed on appeal.

Q: Can I combine Appellate Division work with Court of Appeals work?

A: You may include time spent on a motion for leave to appeal to the Court of Appeals on your Appellate Division voucher. If you prefer, you can voucher the time spent on the Appellate Division matter when the decision is released, and then submit a supplemental voucher for time spent on the motion for leave. If the motion for leave is granted, you will need to start a new voucher for the Court of Appeals matter. Vouchers for work done on Court of Appeals matters should be submitted to the AFC Program. The Court of Appeals decision must be submitted with your voucher.

Q: What court should I select for the appeal voucher?

A: You will select the "4th Dept. Appellate Division" as your court on AFCIV.

Q: The voucher system asks for a case number - what should I input for my appeal voucher?

A: For an appeal voucher, enter the CAF (or CA) Number. This is the Appellate Division's docket number.

Q: What proceeding code applies to appeals?

A: All appeal vouchers should have AP - Appeal for their proceeding code. If you do not select the proper proceeding code, the voucher will be returned to you (the AFC Program cannot fix it on our end), which will result in delayed payment.

Q: The appeal isn't scheduled for Oral Argument for 6 months, can I submit an interim voucher?

A: No. You cannot submit an interim voucher on appeal. You must wait until after Oral Argument, and receipt of the Appellate Division decision.

Q: What if I am unable to attend Oral Argument?

A: Per Guidelines for AFC in the Fourth Department, AFC are expected to attend oral argument. If you do not attend, you will need to attach an affirmation through AFCIV explaining why you were unable to attend Oral Argument.

Q: How should I code my time for Oral Argument?

A: The time spent for Oral Argument should be coded as in-court time. In-court time is defined as time spent in the presence of the justices.

Q: How do I bill the time spent waiting for Oral Argument?

A: Time spent waiting for Oral Argument (outside the presence of the justices) should be coded as an H Code, Out-of-Court All-Other.

Q: Can I combine activity codes? For example, can I combine the time I spent researching case law and drafting my brief?

A: No. You cannot combine activity codes. You must break down activities by proper codes. For example, the time spent researching would be coded as an F Code, Legal Research. The time spent drafting your brief would be coded as an E Code, Legal Drafting. *For further clarification please refer to the AFCIV Reimbursement Guidelines, pg. 13.*

Q: What type of activity description is required?

A: If you are billing an A Code, Review of Documents, you must specify what you are reviewing, e.g., Review Notice of Appeal. If you are billing a D Code, Phone/Correspondence you must specify who you are corresponding or speaking with or what you are composing, e.g., phone call with Petitioner Mother or draft letter to Petitioner's Attorney. Please specify your research topics when billing an F Code, Legal Research. *For further clarification please refer to the AFCIV Reimbursement Guidelines, pg. 13.*

Q: Can I bill for travel, mileage, tolls and parking on appeal?

A: Yes, you can bill for your travel and mileage costs on appeal but you must specify where you are traveling to and from. You must state the office address you are traveling from, and at a minimum, the street name, town and zip code you are traveling to. You

must submit receipts or a copy of your E-Z Pass statement for Thruway tolls. Receipts are required for parking fees over \$5.00.

Q: There is a cap on travel/mileage to and from court. Does this apply to appeals?

A: The cap on travel/mileage does not apply to travel to and from Oral Argument.

Q: Can I be reimbursed for copies and postage on appeal?

A: Yes. We reimburse for copies at the rate of \$.15 per page without a receipt. You must specify in the activity description the number of copies and what document you are copying. Similarly, you must specify what you are mailing and the postage fee. Receipts must be submitted for postage over \$15.00.

Q: Can I be reimbursed for overnight mailing expenses?

A: As a general rule, you cannot be reimbursed for overnight mailing expenses. The exception would be if there is a very short filing deadline, e.g., on a motion for leave to appeal.

Q: Can I be reimbursed for printing of briefs and records, and/or filing and service of briefs and records by a printing service?

A: No. The AFC Program does not pay for fees to professionally prepare and/or file and serve records and briefs. The rules of the Appellate Division expressly allow records and briefs to be reproduced by “any method that produces a permanent, legible, black image on white paper...” (e.g., simple copying). “Binding” can be stapling (see 22 NYCRR 1250.6 [b]; [c]). Filing and service can be effected by mailing with the U.S. Postal Service or by use of a delivery company such as FedEx.

Q: A party has taken an appeal, and so has the child. Who pays for the cost of the record?

Under the statewide Practice Rules of the Appellate Division, per 22 NYCRR 1250.9, on concurrent appeals from a single order or judgment, or on cross appeals, the appealing parties shall file a joint record and shall share equally the cost of the record.

Accordingly, if you are appealing as AFC, and another party is also appealing, please contact the other party and make arrangements to split the cost of the record, including transcripts. Pursuant to the AFCIV Manual and Reimbursement Guidelines, transcript costs are paid by the AFC Program directly to the stenographer or transcriber. The AFC should not pay the stenographer or transcriber. Please see page 10 of the Reimbursement Guidelines for more information, including the rate for transcript preparation. **Please advise the other party that the AFC Program does not pay for fees to professionally prepare and/or file and serve records and briefs.**

Q: I have entered all of my time on AFCIV and am ready to submit my voucher. What do I indicate for disposition?

A: In the disposition section, please explain the outcome of the appeal, e.g., Family Court Order Affirmed.

Q: I was able to submit and print my voucher on AFCIV, where do I send it?

A: Send your voucher with receipts (e.g., postage over \$15.00, parking over \$5.00, and tolls) and any required affirmations directly to the Office of Attorneys for Children at:

Q: Along with the voucher, what else do I need to send to the Office of Attorneys for Children?

A: Please make sure to sign and date the voucher then send the original voucher, with a copy of **YOUR BRIEF** and a copy of the **APPELLATE DIVISION DECISION**. If you do not enclose your brief and the Appellate Division decision with your voucher, your voucher will be returned to you, which will result in a delay in processing and payment.
